18 MONTH - 2 YEAR OLD PRESCHOOL

Classes are from 9:00 a.m. - 2:30 p.m. on Monday and Wednesday or Tuesday and Thursday. This preschool program is designed for younger children who are experiencing their first separation from home. The young preschool incorporates the Little Lambs Curriculum into the day. The curriculum is specifically geared to helping young children learn through Bible-based activity centers. In addition we utilize Frog Street Press Shape and Color curriculum. These children need to bring the following items each day in a bag labeled with the child's name:

- Extra change of clothing in a plastic bag
(several changes if the child is potty training please)
- Lunch and drink appropriate for their age and needs
- Fireproof nap mat for rest time
- Special love items for rest (stuffed toys, blankets, pacifiers, etc.)

All items need to be clearly marked with the child's name. We ask that toddler and two-year-old lunches consist of *healthy* finger foods and no hard candy please. *Do not send lunches that must be refrigerated or heated.*

THREE YEARS OLD – BRIDGE PRESCHOOL

Classes are offered Monday-Friday from 9:00 a.m.-12:00 noon. Our Bible-based Bright Beginnings curriculum provides children with activities that utilize their senses to be creative, explore, communicate and experiment in the world around them. Their day is designed for them to be successful through learning centers in an age-appropriate setting. Their schedule incorporates language development, math concepts, practical living, science, art, cooking, large and small motor development, music, chapel, plus many more creative expressions of fun and exciting learning experiences.

The Three-Year-Old classes compliment the Bible-based curriculum with Zoophonics, Math Their Way and *Handwriting Without Tears* curriculum.

Pre-K and Bridge classes incorporate the *ABeka-Phonics*, *Math Their Way*, and *Handwriting Without Tears* curriculums.

Your child's areas of special enrichment will include:

- 1) **Chapel** - Children will learn of God's love and the wonderful miracles of Jesus through stories and activities that correspond with thematic units.
- 2) **Music and Motor Skills** - Movement activities, rhythm band instruments, finger plays and familiar songs and dances encourage children to develop memory skills. Music is fascinating to children and soothes emotions. It is creative as well as an excellent form of expression. Children will be exposed to structured movement and hands-on opportunities to develop physical skills. Children will also be exposed to age-appropriate movement that will challenge them in a constructive and positive manner.

LAMB JAM

All Three-Year-Old - Bridge preschool children are eligible for Lamb Jam. This is a 12:00 - 2:30 p.m. addition to their day. Children need to bring a *healthy* sack lunch and drink for this program. *Please do not send lunches that need to be refrigerated or heated.*

Children must be enrolled specifically for the Lamb Jam program.

Children who participate in Lamb Jam are provided a curriculum in a less structured environment. They utilize the various activity centers as in their pre-school program. Each day has a theme of science, art, music or storytime.

Young Three year old Lamb Jam children will have rest time and need to bring a fireproof mat. Please label the mat with your child' name.

REGISTRATION

LAMB SCHOOL conducts registration in February for the upcoming school year. All children currently enrolled will be required to re-register.

PARENTS! PLEASE NOTE: Forms are to be completed in full and returned to the school office. Staff will be available to receive the packets ON or BEFORE Thursday, May 31st during the hours of 9:00a.m. - 2:30p.m. In the event your child's completed packet is not received by the above referenced date, your child's space will be filled from our waiting list. Due to the important information in the enrollment packet, your child will not be allowed to attend school until the packet has been filled out completely and received by the LAMB SCHOOL office. Each child will need to have been seen by a doctor within the last six months.

Registration and supply fees are required at the time of registration and are non-refundable. These one-time fees are collected to cover administrative cost and supplies incurred during preparation for the upcoming school year. Accounts must be paid in full by the end of the current school year in order to attend the upcoming year.

REGISTRATION FEE

An annual registration fee of \$80 is due at the time of registering. In the event a child withdraws from the program and chooses to return within the same school year, a readmission fee of \$50.00 will be collected to reinstate them in the program.

SUPPLY FEE

We charge an annual supply fee for each child. This fee is used to purchase educational materials, curriculum supplies, and consumables (crayons, paper, paints, etc.) for your child.

These fees also cover expenses for each child's participation in activities such as in-house field trips, petting zoo, graduation caps, etc. The supply fee is due at the time of enrollment and is non-refundable.

WITHDRAWAL

A withdrawal notice kept on file in the office must be signed and dated on or before the 15th of the month prior to the month my child will withdraw. If I do not give notice on or before the 15th I will pay for the next month's tuition.

SUPENSION/EXPLOSION POLICY

Lamb School provides a safe, peaceful Christian atmosphere and we reserve the right to dismiss a child who is disruptive to this environment.

TUITION

The Lamb School is a non-profit ministry of The MET Church. Tuition is vital to our existence as this is our only source of revenue. To provide the highest possible quality care for your child, the following policies must be maintained:

1. A \$80 non-refundable Registration fee is due at the time of enrollment and upon annual registration thereafter. A non-refundable supply fee is due with completed enrollment packet.
2. Following are the options for paying tuition:
 - Tuition is due on the first of each month or may be paid in advance.
 - A \$10 late fee will be assessed for payment received after the 7th day of each month. If tuition is not received by the 10th day of the month, your child will be unable to attend the program until tuition is paid in full or other arrangements have been made in the office.
 - Tuition may be paid with personal check, cashier's check, money order or through Automatic Withdrawal.
3. Tuition is determined according to the schedule contracted for your child and continues whenever a child is absent. There is no credit for scheduled school closings and holidays, illness, or school closings due to inclement weather and acts of God.
4. Lamb School is closed on the same holidays as Cy-Fair School District. The tuition for the schedule you have chosen will remain the same during holiday weeks.
5. I understand to withdraw my child, the withdrawal notice kept on file in the office must be signed and dated on or before the 15th of the month prior to the month my child will withdraw. If I do not give notice on or before the 15th I will pay for the next month's tuition.

6. Requests for schedule changes should be submitted to the office. Those requests asking to reduce the schedule must give a two-week notice, and will be granted on a space-available basis. Those asking to increase the schedule will be granted on a space-available basis.
7. There is a \$25 fee assessed on all returned checks.
8. Habitual late pick up (after 12:10 pm or 2:40 pm) will result in a \$5 fee per five minutes per child.
9. Lamb School is not responsible for lost or damaged items of clothing or toys.
10. We provide a safe, peaceful Christian atmosphere and we reserve the right to dismiss a child who is disruptive to this environment.

Please do not leave payments on the desk to avoid them being misplaced. Please do not place tuition payments in your child's backpack or weekly envelope, as staff will not be responsible for any tuition payments.

Payment options include a check made payable to the LAMB SCHOOL or automatic withdrawal from a checking/savings account. Returned checks will incur a \$25 fee due upon receipt of the check. Please note that attendance should be on specified program days only. Children are not allowed to make up days. Parents having more than one child in the program will be allowed a 10% discount on the younger child's monthly tuition.

SECURITY SYSTEM

North Access Doors North access doors will open during peak hours of drop off and pick up times. During non-peak hours, all doors will be locked and access to the building will be available by pushing the camera's blue access button located on the brick wall at the far left door. You will be greeted by someone monitoring the camera and receive access to the building.

Hallway Doors Lamb School provides keypad access doors to preschool classroom areas. Doors will be unlocked during peak drop off and pick up times. A Lamb School staff member will be monitoring the door. The keypad lock will require a code to access classroom areas at non-peak hours. Lamb School parents will be given a code at the beginning of the school year by which they may access the hall to the classrooms. Please do not share this code, as only authorized individuals will be given the code for access.

ARRIVAL AND DEPARTURE

It is important that the parent set the tone for a child's school day. In order for your child to benefit from the scheduled activities planned, we encourage you to arrive on time each day. When a child arrives late, it can make his/her transition into the classroom somewhat difficult.

In order to provide a smooth transition for all the children when dropping off and picking up, we ask that you simply knock on the classroom door and wait for a teacher to greet you and your child. This allows every child to be recognized personally without disrupting the classroom routine.

PRESCHOOL - THREE YEAR OLD - BRIDGE

Parents will accompany their children to the classroom using the main entrance to the education building (Bldg. E). The Jones Rd. parking lot is available for Lamb School parents. Parking is also located in the back next to the Toddler playground. Bldg. E is accessible with covered walking from either parking area. The covered drop off area located at the east entrance is used by other church ministries; therefore we request that parents not park in this area when dropping off or picking up their child. **Teachers will be available to accept your child beginning at 8:55 a.m. Afternoon pickup is at 12:00 p.m. for the morning session and 2:30 p.m. for children enrolled in the Lamb Jam program.**

PRESCHOOL - 18 MONTH OLD - TWO YEAR OLD

Parents will accompany their children to the classroom using the main entrance to the education building (Bldg. E). The Jones Rd. parking lot is available for Lamb School parents. Parking is also located in the back next to the Toddler playground. Bldg. E is accessible with covered walking from either parking area.

The covered drop off area located at the east entrance is used by other church ministries; therefore we request that parents not park in this area when dropping off or picking up their child. Teachers will be available to accept your child beginning at 8:55 a.m. Afternoon pickup is at 2:30 p.m.

IMPORTANT: Picking up your child promptly at the close of the day is as important as prompt arrival in the morning. Habitual late pick up (after 12:10 p.m. or 2:40 p.m.) will result in a \$5 fee per five minutes per child. ***If someone other than the parent is picking up a child at the end of the school day, the person's name must be included in the school Authorization Pick-Up Log (located in the school office) as authorized to receive the child.***

This *pick-up* person will be required to present their driver's license to verify their identity. The state requires the school to keep this

information on file for a minimum of 24 hours. **PLEASE REMEMBER TO DRIVE SLOWLY IN THE PARKING LOT AT ALL TIMES.**

CALENDAR

Lamb School is in session September through May. We follow a modified Cy-Fair Independent School District calendar. Yearly school calendars are provided and calendar information is also located on our website at **LambSchoolOnline.com**

INCLEMENT WEATHER

In the event of inclement weather and/or hazardous road conditions, Lamb School closures will be based on Cy-Fair's decision to close. Please watch the local news stations for announcements of school closings, as well as LambSchoolOnline.com and Facebook.com/METLambSchool. Lamb School does not schedule make up days due to inclement weather.

CLOTHING

All items of clothing should be marked with the child's name. Clothing should be comfortable, easy to maneuver for restroom time or diapering, durable and weather appropriate. Closed-toed shoes are equally important. Incidents of injured toes are far less with closed-toed shoes. Due to safety policies, *Heely's* (shoes with wheels in the soles) are not permitted.

ALWAYS send children with an extra change of clothes in their backpack. Some activities may be messy in nature (painting, cooking, gluing, etc.)

Children who are in the process of being toilet trained should have more than one change of clothing including underwear/pants and socks. **Please mark all items with the child's name.**

TOYS

LAMB SCHOOL has equipped each room with age appropriate activities and toys. **Please do not allow your child to bring toys from home. They could be lost or damaged and are not easily shared.**

TOILET TRAINING

We will assist you in toilet training your child once you have developed a plan at home. Please make the teaching staff aware of your desire to toilet train in order to provide an easy transition for your child. Our program requires children to be potty trained prior to entering our **Older Three's program**. Medical exceptions should be discussed with the office prior to the start of school.

HEALTH AND SAFETY

Personal health and hygiene are an important part of our curriculum; therefore, sick children cannot be admitted to the school. Any child who becomes sick during the day will be separated from the classroom setting. We will notify you to pick up your child immediately.

Your child must be picked up within one (1) hour of notification. We will require you to pick up your child with any of the following: *fever of 100.4 degrees or higher, pink eye, diarrhea, vomiting, chicken pox or any other contagious illness*. It may be necessary for you to present a doctor's release for your previously ill child before re-admittance to the school. A communicable disease chart is posted and highlighted by your child's classroom if your child has been exposed. Children will not be readmitted for **24 hours** after having any of the above illnesses.

LAMB SCHOOL DOES NOT ADMINISTER ANY MEDICATION.

INJURIES

Should a child experience an injury while at school, the teacher will immediately advise the administrative staff. The administrative staff will determine the severity of the injury. If the injury is minor (i.e. scrapes, bumps, bruises, splinters, etc.), first aid will be administered. An accident report describing the nature of the injury and the first aid procedure used will be completed. A copy of the accident report will be sent home with the child, and a second copy will be kept on file. Additionally, verbal notification to the parent will be given when the child is picked up at the close of the school day.

In the event of a more serious injury, the staff will administer first aid (teachers and directors are certified in CPR and first aid procedures), dial 911 for assistance if necessary, and contact the parents. If the parents cannot be reached, we will contact the physician indicated on the medical card and transport the child to the hospital of the doctor's choice. If neither parents nor doctor can be reached, we will transport the child to Methodist Willowbrook Hospital for immediate medical care. A member of the staff will remain with the child until a parent arrives.

DISCIPLINE

LAMB SCHOOL strives to be consistent with discipline and guidance of the children. We emphasize understanding the individual needs and development of each child. Often, discipline for inappropriate behavior can be handled with positive reinforcement, redirection, and problem solving. We feel that it is important for children to learn to be responsible for the consequences of their actions. Our focus is directed toward teaching the child acceptable behavior. In the event your child should become very upset after a discipline situation, he or she will be allowed to regroup and regain control before we address the situation again. Should your child be verbally or physically abusive in a persistent manner, you will be contacted for assistance.

DISCIPLINE

LAMB SCHOOL will not subject any child to unreasonable or cruel treatment, humiliation, abusive language, or punishment. In the event we should have repeated behavior concerns that affect the safety of a child or the learning environment of the classroom, (i.e. biting, hitting, inappropriate actions, refusal to follow class or school rules), LAMB SCHOOL will follow the steps listed below of remediation:

- Recorded observation by teacher
- Recorded observation by administrator
- Phone call from teacher
- Phone call from director

If a concern exists after these steps have been taken, the parents will be called by the director to formulate a plan of action with the teacher. Should these steps fail again, dismissal may occur.

IMMUNIZATIONS

The following chart outlines the required immunizations and number of doses of vaccine that your child must receive to follow the Minimum Standards issued by the Texas Department of Protective & Regulatory Services and the Texas State Health Department.

Should your child receive additional boosters during the school year, please advise us so we may make a notation of the date the vaccine was administered. If your child is unable to receive the necessary immunizations, we must have a written statement from your physician stating the reason for the delay. Otherwise, your child will not be allowed to attend classes until the immunizations are current.

IMMUNIZATION REQUIREMENTS

< 2 months	No vaccines required
By 3 months	One dose each of polio, DTaP/DT/DTP, Hib, hepatitis B
By 5 months	Two doses each of polio, DTaP/DT/DTP, Hib, and hepatitis B
By 7 months	Three doses of DTaP/DT/DTP Two doses each of polio, Hib, and hepatitis B
By 16 months	Three doses of DTaP/DT/DTP Two doses each of polio and hepatitis B One dose of MMR, and Hib
By 19 months	Four doses of DTaP/DT/DTP Three doses each of polio and hepatitis Bd One dose each of MMR, , varicella, and Hib on or after first birthday
By 25 months	Four doses of DTaP/DT/DTP. Three doses each of polio and hepatitis Bd. One dose each of MMR, Hib, varicella, and hepatitis A received on or after 1st birthday.
By 43 months	Four doses of DTaP/DT/DTP. Three doses each of polio and hepatitis Bd. Two doses of hepatitis A One dose each of MMR, Hib, and varicella, received on or after 1st birthday.

VISION AND HEARING

LAMB SCHOOL is operated in accordance with the Texas Department of Family and Protective Services, which requires vision and hearing screenings for any child enrolled in a Four-Year-Old or Bridge program. The Special Senses and Communication Disorder Act of 1983 require that all children at the age of four have hearing and vision screening performed by a trained examiner. This screening must have been completed within the calendar year following enrollment in the Four-Year-Old and Bridge program. For your convenience, we will arrange for an examiner to come to the school to administer the hearing and vision screening. Examiners are not employees of LAMB SCHOOL. It is your responsibility to have this screening performed, whether at the school or by a different examiner. You are responsible for all examination fees incurred for the vision and hearing screening.

If you elect to have the screening performed elsewhere, you must provide a photocopy of the actual test for the visual and hearing acuity to keep in your child's permanent record. Verbal notification will not be accepted.

PARENT COMMUNICATION

Classroom schedule, lesson plan, monthly calendar, and any special activities or events are located outside each classroom.

A Parent Information Center is in the office. The snack menu and all important events and information will be posted in the center.

Every child will bring home a monthly newsletter and calendar informing parents of scheduled activities and events. Upcoming events are also located on LAMB SCHOOL website www.lambschoolonline.com, Facebook and texting and emails through One Call Now. **TEXT ALERT to 22300**

The parents of **18 month - Two-year-old** students will receive a daily report to inform them of their child's daily routine.

Three-Year-Old - Bridge age children will be provided with a weekly envelope to transport items and special messages to and from home. Parents are asked to sign the envelope and return it to school each week to ensure proper communication between LAMB SCHOOL and parents.

PROGRESS REPORTS AND CONFERENCES

An ongoing progress report is conducted on each Three-year-old - Bridge preschool child throughout the year. These reports are observation reports and are used as a tool to help the parents see the developmental progress of their child. Parent/Teacher conferences are held in the spring. Parents are encouraged to sign up with their child's teacher for a conference

CHILDREN WITH ALLERGIES

If your child is unable to eat the snack provided by Lamb School, please contact the school office prior to your child's first day of school. In the event your child has a food allergy the following procedures will apply:

School office will provide an emergency health care plan and a snack bin. The snack bin will be filled by parents and given to child's teacher, to be kept in a locked classroom cabinet. The child will only eat snacks provided by the parent. Children needing Epipens, Benedryl, etc. will be given a separate bin specifically for those items, kept in a locked cabinet in the school office. Children with allergies will need to provide all food for events and parties.

SNACKS & LUNCHES

A morning snack is provided for the children each day. **(Please be sure to make LAMB SCHOOL aware of any food allergies your child may have.)**

Lamb Jam children need to bring a lunch. Lunch should consist of *healthy* finger-foods that your child enjoys and a beverage in the form of a drink box.

BIRTHDAYS

Birthdays are always a special time for the children. The school does not allow student birthday parties in the classroom. However, if a parent would like to provide a special snack to share with classmates, please do so. Children having summer birthdays are encouraged to choose a *un-birthday* day to celebrate during the school year. Please make these snacks as simple as possible. We find that cookies, brownies, or doughnut holes are well received by the children. We will be happy to distribute party invitations to ALL classmates.

SCHOOL PARTIES

Parties for holidays are celebrated throughout the school year. These fun events are made even better when our parent volunteers participate in the preparation. Sign up sheets will be posted outside the classroom door for parents to choose how they wish to participate.

VISITATION

Parents are always welcome to visit or be a part of their child's classroom at any time. Please be sensitive that your visit does not disrupt the classroom routine or environment. We encourage you to volunteer and take an active interest in our school wide activities.

PARENT VOLUNTEERS

One of the key factors in the success of any preschool program is the involvement of interested, caring parents. We encourage our parents to volunteer their time as helpers at holiday parties, school wide events, and as "helping hands" when our teachers need extra help cutting/gluing/assembling special projects.

LAMB SCHOOL has a Parent Volunteer Committee that plans and implements special activities and events throughout the school year, such as the Fun Run, Rodeo Week and special holiday parties.

MINIMUM STANDARDS OF TEXAS

The staff of *LAMB SCHOOL* feel very blessed that you have chosen to share the most precious possession you have, your child. We have committed ourselves in every way to help your child grow and learn their value in Christ and that they are a gift from God.

How to Recognize Child Abuse/Neglect

Required Staff Training: Lamb School Staff are trained annually in recognition of child abuse and neglect.

Methods for increasing awareness and warning signs of abuse and neglect:

There are four major types of child maltreatment: physical abuse, neglect, sexual abuse, and emotional abuse.

Physical Abuse is physical injury that results in substantial harm to the child, or the genuine threat of substantial harm from physical injury to the child. The physical injury (ranging from minor bruises to severe fractures or death) can result from punching, beating, shaking, kicking, biting, throwing, stabbing, hitting, burning, choking, or otherwise harming a child. Such injury is considered abuse regardless of whether the caretaker intended to hurt the child.

Suspect Physical Abuse When You See:

- Frequent injuries such as bruises, cuts, black eyes, or burns without adequate explanations
- Frequent complaints of pain without obvious injury
- Burns or bruises in unusual patterns that may indicate the use of an instrument or human bite; cigarette burns on any part of the body
- Lack of reaction to pain
- Aggressive, disruptive, and destructive behavior
- Passive, withdrawn, and emotionless behavior
- Fear of going home or seeing parents
- Injuries that appear after a child has not been seen for several days
- Unreasonable clothing that may hide injuries to arms or legs

Neglect is failure to provide for a child's basic needs necessary to sustain the life or health of the child, excluding failure caused primarily by financial inability unless relief services have been offered and refused.

Suspect Neglect When You See:

- Obvious malnourishment
- Lack of personal cleanliness
- Torn or dirty clothing
- Stealing or begging for food
- Child unattended for long periods of time
- Need for glasses, dental care, or other medical attention
- Frequent tardiness or absence from school

Sexual Abuse includes fondling a child's genitals, penetration, incest, rape, sodomy, indecent exposure, and exploitation through prostitution or producing pornographic materials.

Suspect Sexual Abuse When You See:

- Physical signs of sexually transmitted diseases
- Evidence of injury to the genital area
- Pregnancy in a young girl
- Difficulty in sitting or walking
- Extreme fear of being alone with adults of a certain sex
- Sexual comments, behaviors or play
- Knowledge of sexual relations beyond what is expected for a child's age
- Sexual victimization of other children

Emotional Abuse is mental or emotional injury that results in an observable and material impairment in a child's growth, development, or psychological functioning. It includes extreme forms of punishment such as confining a child in a dark closet, habitual scapegoating, belittling, and rejecting treatment for a child.

Suspect Emotional Abuse When You See:

- Over compliance
- Low self-esteem
- Severe depression, anxiety, or aggression
- Difficulty making friends or doing things with other children
- Lagging in physical, emotional, and intellectual development
- Caregiver who belittles the child, withholds love, and seems unconcerned about the child's problems

Methods increasing awareness:

Child abuse is a community issue. Every person can help make sure the children of Texas have a brighter future. And preventing child abuse is up to all of us. - Support families and provide parents with the skills and resources they need.
- Support providers who are serving families by providing tools and resources.
- Create communities that have supportive services in place and shared goal of safety and stability for families.

Strategies for Coordination between the operation and community:

Here are some things you can do:

- **Get to know your neighbors.** Problems seem less overwhelming when support is nearby.
- **Help a family under stress.** Offer to babysit, help with chores and errands, or suggest resources in the community that can help.
- **Reach out to children in your community.** A smile or a word of encouragement can mean a lot, whether it comes from a parent or a passing stranger.
- **Be an active community member.** Lend a hand at local schools, community or faith-based organizations, children's hospitals, social services agencies, or other places where families and children are supported.
- **Keep your neighborhood safe.** Start a Neighborhood Watch or plan a local "National Night Out" community event. You will get to know your neighbors while helping to keep your neighborhood and children safe.
- **Learn how to recognize and report signs of child abuse and neglect.** Reporting your concerns may protect a child and get help for a family who needs it.
